Report from the Chair

In the spring of 2020, when I stepped into the role of Chair to start my tenure, I knew I was about to lead during a remarkable time for the Valley Hospice Foundation. What I didn’t yet appreciate was the resilience and commitment of the people who make up our new Hospice community.

While this past year has tested all of us in ways that we never could have predicted, it has also marked our time for celebrating more than a decade of persistent work.

I am extremely proud to report that, on September 14 of 2020, we celebrated the official opening of the Valley Hospice.

Following a very busy summer of final touches to the building and detailed operational planning, the Hospice staff welcomed the first residents and their families to the Valley Hospice. We are grateful for the legions of people who have played a role over the years leading to this day. Everyone in the Annapolis Valley should be proud of the significant role that this Hospice is playing in the care of families coping with end-of-life.

The Valley Hospice Foundation continues to work directly with our partners, Nova Scotia Health (NSH) through the Integrated Hospice Palliative Care (IHPC) Advisory Committee. Over the past year the Committee has shifted their focus away from planning the building of Valley Hospice towards ensuring operational needs are met and programs continue to grow both in the Hospice and the community. Together we are committed to providing the best end-of-life experiences for palliative patients and their families across all care settings.

In December we were heartbroken when the Hospice experienced a flood that damaged five of the ten bedrooms. We are very proud of the NSH staff and the hospice team of professionals who responded quickly and diligently to ensure that the quality of care of hospice residents and their loved ones was never compromised. It was a pleasure to welcome the residents back to their Hospice home following a two month stay at Valley Regional Hospital.

Over the past year we increased our commitment to strategic planning. Work has been completed in terms of the development of policies, procedures and tools to ensure robust accountability to our stakeholders. I thank the members of the Board who have given their all in tackling the steps required to set a path towards transforming our organization to deliver on our mission to support and promote Hospice and Palliative Care in the Annapolis Valley.

Despite lockdowns and other restrictions due to the Covid-19 pandemic, our Fund Development team got creative with altering planned events and we have met our 2020/21 financial goals. We had a great time staying connected through a virtual Garden Party and our Flannel Tie Gala from home. We were also fortunate that our Hike for Hospice – Fall Edition landed at a time when we could safely hike together. The extraordinary generosity we received in donations this year is a remarkable expression of support and love for the work of our Hospice and Palliative Care teams.

We’re proud of the work that has been accomplished this year — but we know there is much more to do. The values of our founders and the voices of our community and partners will continue to guide us as we turn the page towards a new year.

Strategic Planning

The Strategic Planning Committee (Martha Stewart, Shelagh Campbell-Palmer, Robbie Harrison and Wayne Woodman) continued to meet to discuss and revise the plan based on feedback from Board members. The strategic plan has precipitated a number of governance tasks to be completed including the writing of terms of reference for both ad hoc and standing committees of the Board. As well, a Risk Management Committee was formed that included Board members Gerry Morey, Diana Patterson and Shelagh Campbell-Palmer. Their hard work resulted in the passing of a Risk Management Policy as well as creating a Risk Register for other Board committees to use. Gerry Morey and Diana Patterson were joined by Kathy Phillips in researching and developing a Board Self-Evaluation tool that will be administered in the fall. Other activities stemming from the strategic plan are noted in the Fund Development and Finance reports. The strategic plan has been shared with Nova Scotia Health members on the Integrated Hospice Palliative Care Advisory Committee in an effort to collaborate on shared priorities and responsibilities.

Risk Management Committee

During the Valley Hospice Foundation's work in 2020 to develop a revised Strategic Plan, the need to provide more robust risk management oversight for the Foundation was identified. Consequently, in mid-2020, an ad-hoc committee was struck to begin work to develop a risk management framework for the organization.

Through late 2020 to present, the committee, consisting of Gerry Morey, Diana Patterson and Shelagh Campbell-Palmer, undertook the following work:

1. The Board was provided with general resources on Risk Management and the Committee recommended that a consultant be enlisted to provide Board education that would result in a consistent understanding among Board members regarding the importance of Risk Management and what components of a Risk Management framework would be needed. Maureen Reid of BoardWorks Consulting provided an evening educational session to the Board in November 2020.
2. The Committee developed the following documents to facilitate ongoing Risk Management:
 - a. Risk Management policy which was approved by the Board in February, 2021,
 - b. Risk Register/ Risk Matrix - all risk items were mapped to the Strategic Plan where appropriate, and
 - c. Committee Terms of Reference.

A Board Conflict of Interest policy and Code of Conduct are being developed for approval and although these are not typically part of a risk framework, the risk work prompted and shaped their creation. Ultimately, the tools developed will be used by all Board Committees to monitor any risks specific to their work. Once all committees have reviewed their elements of the Risk Register, ongoing risk oversight of the Board as a whole, including to ensure that the risk register is being maintained, risk management at the committee level is happening and being reported back to the Board, will be the responsibility of the Executive Committee. The identified risks may influence the activities that need to be undertaken the Board and will be considered when developing the next year's macro agenda.

Governance Board Evaluation Committee

The Valley Hospice Foundation Board is responsible for achieving the organization's social mission and ensuring that the organization is viable. It is also responsible to ensure that the processes for making and implementing decisions will continue to advance these principles, its strategic plan, and mission.

The ad hoc Governance Board Evaluation Committee was formed to establish a process and a tool by which the effectiveness of the Valley Hospice Foundation Board's purpose and direction, its committees, and each Board member could be assessed.

The Ad Hoc Governance Board Evaluation Committee researched and reviewed various board governance analysis formats and tools. One was selected and modified to meet our unique purpose. Each Board member, through small group dialogue and individual input, had the opportunity to make suggestions for change and improvement, ask for clarification, and request additional elements. The Ad Hoc Governance Board Evaluation Committee revised the evaluation tool and it is ready to be administered in August/September 2021. The exact means by which the results will be processed, respecting Board member anonymity, will be determined according to Covid restrictions for in-person gathering.

The Ad Hoc Governance Board Evaluation Committee is comprised of three Directors: Gerry Morey, Diana Patterson, and Kathryne Phillips.

Fund Development Committee

This year was like no other for everyone in every way. COVID 19 affected plans across the world and the Valley Hospice Fund Development Committee was no exception. We typically hold three fundraising events each year where people gather and each of these was affected. In addition, we had imagined that the opening of the hospice would be a large celebratory event that would bring people together to commemorate the many years of work and commitment. By necessity, the opening of the hospice involved a relatively small gathering of people outside the hospice building.

In spite of these challenges the Fund Development Committee planned and executed some unique fundraising events. The Hike for Hospice was moved to the fall when we were able to hike in “bubbles”, the summer event became an online garden party, and our dressier event was a “Flannel Tie Gala” which provided an opportunity to purchase a ticket to a comfy and enjoyable night at home.

We did not publish a spring newsletter as the date for hospice opening was not yet set and we wanted to share good news during challenging times. We did publish a late fall newsletter detailing the hospice opening and this was well received.

The number of people committed to monthly giving through the Circle of Care grew and this regular commitment of funds helps in planning.

A donor wall for major donors was installed in the hospice and a donor book was created to honour all others who contributed to the hospice. We established an online annual donor wall and began publishing memorial and tribute donations quarterly in the local paper.

In planning the online garden party, the committee recognized that there needed to be some work done to the hospice grounds to ensure that gardening could proceed and the view out of each patient room would be one of beauty and tranquility. To that end we arranged for dead and fallen trees be removed before the hospice opening. This significantly improved the beauty of the area behind the hospice and set the stage for ongoing fundraising for the development of the grounds.

The targets for fundraising this year were the Care and Comfort Fund and the beautification of the hospice grounds. The fact that the Fund Development Committee exceeded its fundraising goal this year in spite of challenges is a tribute to the community’s commitment to the hospice and the generosity of our donors.

Financial Report

Finance Committee: Wayne Woodman, Mike Townsend and Don Wells.

The total assets of the Valley Hospice Foundation as of March 31 2021 are: \$1,509,093.

- During the fiscal year of 2020/21 a second installment in the amount of \$1,209,382 was paid to the Nova Scotia Health Authority (NSHA) towards the construction of the Hospice.

A formal agreement between the Valley Hospice Foundation and NSHA states that additional installments will be made by the Foundation as billed by NSHA up to a total contribution of \$4 million. Total amount paid to date is: \$3,209,382. A final invoice for the construction is currently being reviewed by the Board representatives of the Hospice Palliative Care Advisory Committee prior to approval for a final payment.

- Over the past year the Valley Hospice Foundation continued their support of the Hospice. A total of \$26,037 was spent to enhance the gardens, purchase patio furniture, and to provide artwork for the walls. Also, \$5731 was spent on “Care and Comfort” items for Hospice residents and their families.
- Funds valued at \$1,249,214 are invested and managed by Scotia Wealth Management using a low risk asset mix of: 80% Fixed/20% Equities. Tasks that were identified through the Board’s Strategic Planning process has led to a review of current policies. A revised draft of the Investment/Endowment Policy will go for Board review/approval in the Fall 2021.

The Valley Hospice Foundation’s audited statements are available to the public for review.
