### **Report from the Chair**

The Valley Hospice residence is now in its second year of operating since the onset of Covid-19. Despite the challenges that the pandemic has presented, the amazing care teams, both in the Hospice and in our community, have adapted to measures for keeping their patients, families, and each other safe while also preserving the compassionate culture that defines hospice and palliative care. We are most pleased and proud of the comments and stories that we receive from staff, patients, families, and friends who work and have stayed in or visited our Hospice. As a community, we should all be so proud of creating such a comforting, safe space for people to live their final days.

Our work with Nova Scotia Health has been more challenging this past year as staff was required to direct their efforts into managing the pandemic. Regardless, the Integrated Hospice Palliative Care Advisory Committee were able to lay the groundwork for a couple new projects that we hope to introduce in 2022/23.

Fundraising for Hospice and Palliative Care remains critical to the Foundation's work. We put emphasis on keeping the community engaged through newsletters and events. We are in awe of how our community has persevered in their support over the past year. We enjoyed staying connected during our virtual Hike for Hospice in May 2021. We were also fortunate to be able to safely come together for our *Gathering in the Garden* in August and again in November for our return to the historic Ball Room at the Main Street Station for a *Holly Days Holiday Party* that was designed to wrap up our very first *Holistay Raffle*.

This year we teamed up with the Nova Scotia Hospice Palliative Care Association in offering public education and awareness of Advance Care Planning. Valley Hospice Foundation represents the region on the Nova Scotia ACP Advisory Council. Going forward we will support a team of volunteers who are trained and prepared to provide presentations in the Valley community.

I take this opportunity to acknowledge the ongoing commitment by Board members to explore new ideas. This past year, the VHF has continued to make significant progress on several of the key initiatives outlined in the current Strategic Plan. Directors and staff have been working with a focus on governance. The work has resulted in the revision and development of several policies which will serve to enhance decision-making processes and board accountability. We went through our first Board Evaluation process, and the board has begun to address important items that were identified for improvement.

In closing I hope that you will join me in recognizing some great individuals for their unwavering commitment to our hospice family. It is bittersweet to be saying farewell to long standing and key members of our Foundation's Board of Directors: Brenda Wallace-Allen, Diana Patterson, Robbie Harrison, Don Wells, and Shelagh Campbell Palmer. Earlier in the year, we said goodbye to Kathy Phillips and Dr. Lori Burgess.

They are among the pioneers in the hospice movement in the Annapolis Valley and can leave proudly knowing that their service has resulted in the first rural hospice residence in Nova Scotia. They leave our organization with a path to move forward with a strong foundation that they have built with our community. We thank each of them for all they have done to help us succeed.

## **Governance – Risk Management**

Subsequent to the development of the necessary tools to manage risks to the Foundation during the previous year, 2021/22 saw further amendments/additions to the Risk Register and a number of activities that contribute to the Foundation's risk oversight.

One of the most significant risk management activities by the Board in the past year has been the re-working of the Board's policy framework, including the development of a working group that is in the process of updating all policies that relate to Board operations and oversight, including a new process for Board Self- evaluation. This process was used successfully during the year and resulted in the identification of a number of additional quality improvement initiatives for effective Board functioning.

A risk management lens is being applied to all of these activities in addition to being incorporated in the Board's strategic planning process and its macro agenda. The inclusion of annual review of risk management activities in the macro agenda will also serve to keep risk management 'top of mind' for all Board members and Committees and ensure that the Risk Register is appropriately amended as the Board evolves and grows and ultimately mitigate harm to the Foundation where there are existing risks.

#### **Governance - Board Evaluation Committee**

The Valley Hospice Foundation Board is responsible for achieving the organization's social mission and ensuring that the organization is viable. It is also responsible to ensure that the processes for making and implementing decisions will continue to advance these principles, its strategic plan, and mission. The ad hoc Governance Board Evaluation Committee was formed to establish a process and a tool by which the effectiveness of the Valley Hospice Foundation Board's purpose and direction, its committees, and each Board member could be assessed.

The ad hoc Governance Board Evaluation Committee administered the Board Evaluation tool to the Board in October 2021. Each Director was able to respond anonymously, and responses were received from all Directors. The Board Evaluation Tool posed 63 questions in the following seven key areas:

- A. Board Roles and Responsibilities; Staffing & Equipping Board Members; Board Policies
- B. Board Committees and Meetings
- C. Strategic Planning
- D. Foundation Programs & Fund-Raising
- E. Board Oversight of Financial Activities & Legal Matter
- F. Board Oversight of Personnel Management
- G. Board Participation and Morale

The results were tabulated and reported to the Board. Areas E and G reported high degrees of satisfaction among the Directors. The other areas were generally perceived as having met the Board's Directors with some areas requiring work or improved communications. Notably many of the observations were being addressed by recently struck Committees. Key recommendations arising from the review were:

- A. Update the Board manual and distribute to each Director.
- B. Update the Foundations policies and TORs

The Board Evaluation Tool was deemed useful though needed revision for more relevancy in certain areas.

#### **Governance – Terms of Reference Committee**

The Valley Hospice Foundation (VHF) Board is a manifold and complex organization whose work is planned and delivered by a set of Officers, an Executive and a myriad of standing and ad hoc committees. In order to provide structure and focus for the offices and committees a Terms of Reference Committee was struck to assist in the creation of clear, complete, coherent and unique Terms Of Reference.

The TOR Committee met throughout the fall and winter. Initially a review of the Terms of Office of the Directors and the Officers of the Board as expressed in the 2018 Bylaws was conducted. Several issues were raised including the burden of the four officer positions was being borne by two persons. Additionally, the length of the terms was confusing and potentially conflicting. A Vice Chair was elected to address the first issue and the second is the subject of proposed changes to the Bylaws.

The TOR Committee has revised or produced TORs for approval for the Board of all Standing and Ad Hoc Committee with inputs from the members of the relevant committees. Most, if not all, of the TORs will have been approved by date of the AGM.

#### **Fund Development**

The Fund Development Committee was busy in spite of the challenges presented by a second year of pandemic requirements. We were glad to welcome a new committee member, Terri Milton, and were happy to have people step up to serve on committees and volunteer on the day of events.

The Hike for Hospice was affected by COVID restrictions, so we held a virtual hike through the month of May 2021 where people hiked on their own or in their bubbles. This meant that the traditional gathering of hikers was affected but those who accepted the challenge to hike virtually posted lovely photos and comments of their experience.

We set a summer goal of purchasing a garden shed that the hospice garden volunteers could use to hold tools. The online gardening community responded positively to the opportunity to raise money for this cause and in the fall the new shed was installed. Joe and Susan Ueffing offered the use of their beautiful Open Garden for an August garden gathering and a large crowd came to see the gardens and offer a donation to the work of VHF.

Through the summer, plans were made for the first Holistay Raffle with ten prize packages worth a total of \$10,000.00. The raffle was launched just after Labour Day with the prizes being awarded at a Holly Days Holiday Party in November. This year the Holiday Party replaced the traditional gala. The venue was selected to accommodate the smaller numbers of participants as required by COVID requirements and participants responded to the change very positively. This full fundraising initiative was deemed worthwhile and will be offered again in 2022.

Two newsletters went out in 2021, one in the spring and one in the fall. Analysis by the committee determined that these newsletters are a great vehicle for keeping donors and community members informed of VHF activities as well as generating funds.

The virtual donor wall was updated and maintained. We have just added an acknowledgement section for "Special Gifts". Tributes and in memorial gifts continue to be acknowledged regularly through local media.

Once again during a period where the pandemic affected operation of Valley Hospice, prevented large gatherings and impacted our ability to offer fundraising events in a traditional manner, the community responded generously to fill any gaps.

#### **Succession Planning and Nominating Committee**

The Valley Hospice Foundation will see a significant retirement of many long standing Directors who have contributed significantly of their time and talents over the past years and in some cases decades. To address this large loss of personnel and unique skills, VHF struck a Succession Planning and Nominating Committee (SPAN) which added a succession planning element to the existing Nominating Committee.

The SPAN Committee met several times over the winter to assess the short, medium and long term needs of the Foundation in terms of numbers and skill sets. A plan was briefed to the Board to recruit and nominate a strong cadre of new Directors to address critical skill areas.

The SPAN Committee identified a need for a limited number of new Directors to address specific skill gaps arising from the departure of several longstanding Directors. A recruiting plan was developed and implemented by Don Wells resulting in the nomination slate which will be presented during the Election of Directors at the AGM.

## **Financial Report**

The VHF Finance Committee is responsible for the oversight of all financial matters and assists the Board in fulfilling its duties regarding financial stewardship, reporting and legal compliance. This past year the Committee has produced a revised Investment Management Policy that has been presented and approved by the Board. Investments are strategically invested on a long-term basis, among several classes of assets to reduce the risk of investment volatility.

Total assets of the Valley Hospice Foundation as of March 31, 2022, are recorded to be: \$907,625. The portion of assets that are invested is valued at \$735,234. The Valley Hospice Foundation's audited statements are available to the public for review.

- During the fiscal year of 2021/22 the final installment in the amount of \$687,752 was paid to the Nova Scotia Health Authority (NSHA) completing the Foundation's commitment to the construction of the Hospice. The total amount paid for construction of the Valley Hospice is \$3,897,134. The Foundation will continue to review for approval funding requests for additional building enhancements.
- A total of \$13,792 was spent to enhance the gardens, purchase planter boxes, and provide a garden/storage shed on the property of valley Hospice.
- \$4,318 was spent on "Care and Comfort" items for Hospice residents, and their families. (Specialized night gowns, guest slippers, personal items, pantry items, taxi fares, and special occasion celebrations).
- \$2,557 was granted to Friends in Bereavement Program. The program offers support groups in Kentville, Berwick and Bridgetown, however a portion of the program was forced to pivot to virtual meetings due to the risks of Covid still present in the community.
- \$217 was spent for staff to attend a virtual workshop on introducing Complementary Therapies in a Hospice setting.
